A SPECIAL MESSAGE from our MEMBERSHIP DIRECTOR Angelo Costanza - 588-9529

Under our SIR State Charter rules members are required to attend all regular luncheon meetings in a running twelve month period. An exception to this rule allows for absences due to illness or other personal reasons providing that at least one-half of

the regular luncheon meetings are attended (Ladies Day, the Annual Picnic and our Christmas Luncheon are not counted).

Thus we have nine (9) regular meetings per year.

In regards to this exception, members may miss up to three (3) consecutive regular meetings - having been excused by contacting the membership message line prior to the meeting at 536-6311 and leaving a message with their name, badge number and the reason they will not be attending.

Please note that these excused meetings cannot be included to achieve the minimum attendance requirement of one-half of the regular meetings.

However, missing three (3) consecutive regular meetings without having been excused may result in a member being notified of a pending termination (Article 8 -Required Attendance, Rule 100)

The reason I am restating our attendance requirements is because we currently have 11% of our membership with an attendance rate of 44% or lower. This means that of nine (9) meetings they should have attended in the last twelve (12) months they only attended four (4) or less.

In addition, out of an average of 60 members that didn't attend our regular luncheon meetings this year only an average of 17 called the membership line or the attendance & membership director requesting to be excused.

This is only a 28% call-in rate and it should 100% because the membership message line (536-6311) is a recorder! Just call and leave a message as to why you can't attend.

Please remember - if you are having any health issues or any other personal problems that preclude you from attending a regularly scheduled luncheon meeting - call in and let us know. If you know you will be absent for an extended period call me and request to be put on inactive status so as to preserve your membership in good standing.

Also, If you are in the Branch 136 Propane Co-op and you lose your membership you also lose your propane discount!
