Call to Order – Big SIR Rick Bronner called the meeting to order at 10:06 am.

Roll Call – Secretary Steven Holt took attendance and informed the board that a quorum was present.

Approval of Agenda – Big SIR Rick Bronner asked if there were any additions or deletions to the agenda. Eddie informed the group that Dale Decker's wife Lea had passed away on Friday. A card was passed around for people to sign. Steve Gregory to provide a pray with today's luncheon.

Secretary's Report – June 2024 minutes approved by the board.

Treasurer's Report – Treasurer John Salmon presented the following financial report for June 2024.

In June, Branch 136 reported an ending checking account balance of \$17,535.72, with \$150.00 cash on hand. General Fund Receipts: Bulletin Ads of \$40.00, Luncheon profit of \$93.00, Raffle proceeds of \$100.00. Custodial Fund Receipts: Luncheon \$1,077.00, Picnic Tickets \$825.00. General Fund Disbursements: Printing, Supplies and Taxes \$47.59, Postage \$35.28, Rent, Setup, and Cleanup \$470.00, Domain Name Yearly Fee of \$20.17, Birthday lunch \$20.00, and Raffle Payout of \$50.00. Custodial Fund Disbursement: Luncheon \$1,077.00, Ladies Day Luncheon Donation of \$200.00, Badge \$8.65.

Final Ending Balance of \$15,160.04.

Big SIR Report – Rick Bronner

1. Discussed the option of moving to the Moose Lodge. We were offered to lodge rent free and the meals / menu would remain the same. The downside was the lack of any TV monitors for future presentations.

One plus was the outdoor bar-b-que facility at the Moose lodge, which includes a playground with grass. Parking doesn't seem to be an issue. Eddie disagreed with the adequate parking comment. Eddie also raise his concern about the possibility of future rent verse staying rent free.

The Elks had stated the current monitor system switch has failed and a \$600.00 replacement is on order. One outstanding question is if the new switch will be compatible with the current system. SIRs will be responsible for one-third of the replacement cost (\$217.00).

After a lengthy discussion, Branch 136 would prefer to stay with the Elks. The big outstanding question is how do we deal with the cost increases?

Eddie had a meeting with Don? where the lodge pricing was dropped to: Rent of \$275.00, Set-up of \$40.00 and clean-up of \$100.00 totaling \$415.00 per month.

A discussion continued, should we raise the monthly meal cost to \$25.00 or increase yearly dues to \$35.00 or \$40.00 offset the recent price increases. This was motioned and approved that yearly dues would be increased to \$40.00 starting 2025. This dues increase would be presented at today's luncheon.

Eddie also demanded we increase the price of the extra lunches to \$10.00.

2. A sound system was sourced by Rick which will cost \$199.00 from Amazon. A motion was made to purchase, by Eddie, and approved by the board.
