Call to Order – Big SIR Rick Bronner called the meeting to order at 10:02 am.

**Roll Call** – Secretary Steven Holt took attendance and informed the board that a quorum was present.

**Approval of Agenda** – Big SIR Rick Bronner asked if there were any additions or deletions to the agenda. Two additions were made to the agenda for today. Eddie was going to discuss Dale Decker's status and the Elk's had presented the new 2024 / 2025 venue contract.

A status update was also provided on Mike Krom.

**Secretary's Report** – April 2024 minutes approved by the board.

**Treasurer's Report** – Treasurer John Salmon presented the following financial report for April and May 2024.

In April, Branch 136 reported an ending checking account balance of \$17,535.72, with \$150.00 cash on hand. General Fund Receipts: Bulletin Ads of 150.00, Dues collected \$60.00, Luncheon profit of \$48.00. Custodial Fund Receipts: Luncheon \$1,187.00, Ladies Luncheon \$1,635.00. General Fund Disbursements: Printing, Supplies and Taxes \$56.39, New checks for \$186.49, Postage \$19.26, Rent, Setup, and Cleanup \$300.00, Quarterly assessment \$335.00, Table cloths for the Home Show was \$39.65. Raffle ticket purchase \$23.58, Sponsored lunches \$20.00, Birthday lunch \$20.00. Custodial Fund Disbursement: Luncheon \$1,187.00, Luncheon ticket refund of \$70.00, Table linens for \$272.47, Cash prizes of \$225.00, Badges \$8.65.

In May, we had an ending checking account balance of \$14,943.73, with \$150.00 cash on hand. The raffle took in \$505.00. General Fund Receipts: Ticket sales of \$280.00. General Fund Disbursements: Printing, Supplies and Taxes \$70.32, Postage \$19.26, Rent, Setup, and Cleanup \$300.00, Custodial Fund Disbursement: Luncheon cost of \$2,860.00, Luncheon ticket refund of \$70.00, Table linens for \$35.28, Miscellaneous supplies of \$12.13.

Final breakdown for the Ladies Day Luncheon showed a loss of \$327.74 for this event.

## **Big SIR Report** – Rick Bronner

1. A new Elk's contract was presented to Rick, before the start of today's meeting, for the 2024 / 2025 which increased rent for the lodge. The increases included \$330.00 for rent, \$75.00 for setup, and \$100.00 clean-up. This would be a total of \$505.00 per month. These price increases are retroactive to April 2024.

Dino had confirmed there is a zero increase in meal cost for 2024. The question is how we cover the cost increases for the coming year. Do we raise membership dues or raise meal prices to cover these costs increases or both? Rick recommended we keep everything the same, start discussions with our members, and table this until our November meeting.
